# Juan Alvarez-Vijande elected as the new Chairman of ecoDa

In addition to his board experience as Senior Executive during more than 15 years, Juan Alvarez-Vijande served as CEO/MD/CD in multinational companies and affiliates.

All his experience will undoubtedly contribute to pursue the objectives of ecoDa. "The current crisis propels more than ever ecoDa at the core of the diverse European business and shareholders organisations. ecoDa will have to intensify dialogue with European stakeholders involved in Corporate Governance to face its responsibilities", added Juan Alvarez-Vijande.

ecoDa will also try to extend its membership by approaching new institutes of directors but also organisations willing to join their forces to face new challenges.
